#### From the Airport to the Hotel:

The easiest way to get from the airport to the hotel is by taxi.

You can take a regulated taxi from the airport taxi stand. Recommended cost: 150-180 NIS.

Cheaper taxies can be ordered by apps from: Gett or Yango. Just download the apps from the application store and order.






If you feel more adventurous you can take the train from the airport to the "Hagana" stop, and from there a taxi to the hotel.

## Israeli Currency

50

The Israeli coin is called a Shekel. Its current value is about 3.54 New Israeli Shekel per 1 €. 1 Shekel equal 100 Agorot.

The coins include 10 Agorot, 50 Agorot, 1 Shekel, 2 Shekels, 5 Shekels and 10 Shekels.

Folds include 20 shekels, 50 shekels, 100 shekels, 200 shekels. More info in this link

## Credit card or cash?

Credit cards are widely used in Israel, even for small amount like a cup of coffee. Most places will receive Visa or Mastercard. American express in not always excepted. But you should have some cash with you as some vendors and taxi driver might not receive cards.

#### How much to tip?

Leaving a tip even for a cup of coffee is very common and expected in Israel. The minimum tip left will normally be calculated as 10% of the sum.

**Currency: NIS New Israeli Shekels** 

Time zone: Time zone in Israel (GMT+2)

Official languages: Hebrew, Arabic, (special status)

Tipping: Service and VAT is always included in the menu price. Service sometimes not. Therefore, it is typical to tip 10%-15%.

Weather: As Israel does not get much rain, in February you can enjoy sporadic rain or dry weather with temperatures during the day ranging between 20°c and 15°c) and cold nights (ranging between 10°c and 2°c).

























#### 7. Facts about Israel

Tel Aviv is the second largest city in Israel (after Jerusalem) with a



population of close to half a million people. it is one of largest economies per capita in the world and right now it had the highest cost of living in the world. It is the most modern and liberal city in Israel with abundance of LGBTQ+, vegan and human rights establishments. Its population is composed of 95% Israeli Jews.

The Negev - a desert or semi-desert area south of Tel Aviv. The Negev



comprises 55% of the land of Israel but less than 10% of the population reside there. The population consists of around 75% Jews and 25% Bedouin. About half of the Bedouin live in unrecognized villages that are not connected to municipal energy and government sources.
